The DCAA Hotline provides DCAA contractors and employees with a confidential means of reporting suspicious activity concerning fraud, waste, abuse (FWA) and gross mismanagement.

### WHO OPERATES THE HOTLINE?

The Office of the Inspector General manages the DCAA Hotline. Calls are taken by highly skilled and trained investigators with professional expertise in the areas of audits, contracts, security, investigations, and inspections.

### WHO SHOULD CALL?

DCAA civilian employees, DCAA contractor employees, as well as private citizens.

### WHEN SHOULD YOU CALL?

Disclosure should be made as soon as you become aware of actual misconduct pertaining to FWA. The Hotline telephone and the Hotline website are available 24 hours a day, 7 days a week.

## WHAT YOU SHOULD EXPECT

A thorough interview by an OIG investigator. You will be asked to provide information that will help the investigator piece together the facts of the situation (who, what, when, where, and why) and assess the estimated dollar loss to the government if monetary issues are involved.

An evaluation of your complaint will be made to determine if an investigation is warranted or if you need to refer the matter to other authorities.

Your call will be handled with confidentiality and you may remain anonymous, if you desire.

Anyone making a report to the Hotline is protected from reprisal.
