Ms. Lori Tucker assumed the position of Deputy Assistant Director, Human Capital and Resource Management, Defense Contract Audit Agency (DCAA) in May 2023. Ms. Tucker serves as principal advisor and Deputy to the Assistant Director, managing and directing the Agency's human capital resources (~4K employees), learning and development, and financial management, to include budget (\$~660M) and accounting programs. As the Deputy, she also has oversight security, procurement and acquisition, and a variety of administrative, support, and logistic programs, studies, and initiatives on behalf of the Agency.

Ms. Tucker is an Illinois native, served active duty in 1982 in Logistics and transferred to the Air Force Reserves in 1992. She entered into the Federal Civil Service in 1993. Her diverse cross-functional expertise has proven to be an invaluable asset. She is recognized for her unique expertise and many cross functional assignments with financing/transforming complex logistic systems, joint operations, and Human Capital management. Her financial breadth includes budget, cost, revolving/working capital, FM Systems, and program management at HAF/SAF, MAJCOM, COCOM, and Base level. Prior to coming to DCAA, Ms. Tucker served as the SAF/FME Director of Workforce Management and Executive Services, Office of the Deputy Assistant Secretary of the Air Force for Financial Management & Comptroller, Headquarters USAF, Washington, D.C. In this position, she served as the SAF/FM's senior advisor and principal point of contact on all matters pertaining to enterprise career development & training of the DAF FM workforce and AF FM Strategic Planning. Ms. Tucker has also served in joint operations as the Chief of the Cost Analysis and Program Assessment Division for United States Transportation Command (USTRANSCOM) where she was responsible for directing complex financial cost activities, joint program assessments and Planning, Programming, Budgeting Execution (PPBE) Integration for \$8B dollar enterprise.
