Ms. Sharyn Elliott assumed the position of Assistant Director, Human Capital and Resource Management (HCRM), Defense Contract Audit Agency (DCAA) in June 2024. Ms. Elliott serves as the principal advisor to the Director and provides executive leadership in human capital management and oversight of plans, policies and programs that affect over 4,000 DCAA employees. She oversees and manages an annual operating budget of approximately \$660 million for over 230 audit offices located in the U.S. and overseas. Ms. Elliott's portfolio spans the entirety of the human capital lifecycle including talent acquisition, leader development and succession planning, performance management, and strategic workforce development. She is also responsible for security, logistics, and facilities management. Her expertise in these areas ensures the Agency is equipped with the essential resources needed to successfully accomplish its audit mission.

Ms. Elliott was appointed to the Senior Executive Service in January 2014 and possesses an extensive background in human resources with experience in strategic-level human resources, performance management, programming, and administration. Ms. Elliott served as the Assistant Administrator for Human Resources at the Drug Enforcement Agency (DEA), part of the Department of Justice. She oversaw all human resources and medical services. She also managed the DEA Training Academy in Quantico, Virginia, and supported 23 domestic field divisions, 239 field offices, and 91 foreign offices in 69 countries. Prior to DEA, Ms. Elliott was the Director of the Army Resiliency Directorate at the Department of the Army, Assistant Deputy Chief of Staff. In this position, she led a community of 36,000 personnel through a cultural transformation. Her focus was on developing plans and policies to enhance personal readiness for units, soldiers, civilians, and family members through proactive steps aimed at enhancing physical, psychological, social, and spiritual preparedness.

Ms. Elliott has over 30 years of professional leadership experience in human capital, program, and operations management in challenging and highly competitive environments. Prior to DCAA she served as the Director, Defense Logistics Agency, Human Resources, J1. She led a team of 1,000 professionals responsible for human resources, training and served as a DoD HR Service Provider for a worldwide population of 65K with service to 7 commands and 16 DoD agencies.

Ms. Elliott graduated from University of South Florida in Tampa, Florida with a Bachelor of Arts, and she received a Master of Business Administration from Western Governors University, Salt Lake City, Utah. She is a graduate of the Stanford Executive Program, the Executive Development Program at University of Notre Dame, the Army Senior Leader Executive Education Program, the Air War College, and the Air Command and Staff College. She has received numerous awards and recognition of excellence in performance throughout her distinguished career with the Department of Defense.
