Ms. Chanae Jones was appointed as the Corporate Audit Director (CAD), Corporate Audit Directorate – Boeing, Defense Contract Audit Agency (DCAA) in April 2022. Ms. Jones serves as the principle advisor to the Director and is responsible for strategic management and operations of the CAD-Boeing and its resources. Currently, Ms. Jones leads over 250 employees in execution of the CAD’s mission in providing contract audit, accounting, and financial advisory services to the Department of Defense, Executive Departments and foreign governments. She oversees and manages an annual operating budget of approximately \$40 million.

Ms. Jones has over 21 years of extensive experience in areas such as accounting, auditing, and has served in field and regional leadership positions for 14 years. Her DCAA accomplishments include strengthening coalitions with internal and external partners to accomplish the Agency’s priorities, such as high-dollar/high-risk proposals and major incurred cost assignments. She focuses on effective communications to establish and maintain a vast professional network and leverages professional relationships to gain support for key programs and initiatives. In addition, she has served as a Federal Executive Board Leadership Mentor to foster collaboration and expand knowledge about the Federal government.

Prior to joining the CAD, Ms. Jones served as the Western Regional Special Programs Manager and was responsible for providing quality audits and advisory services to Western Region external stakeholders while managing a diverse portfolio of special programs. She began her federal government career in 2000 as a junior auditor in Field Detachment at the Antelope Valley Branch office in California. In 2005, she was promoted to a Financial Liaison Advisor to the Field Detachment, Headquarters. In 2007, she was selected to her first Supervisory Auditor position at the Reston Sub-Office in the Field Detachment and later relocated to California to manage the LAX Sub-Office. In 2008, she was reassigned to Seal Beach Sub-Office for a short tour before heading up the El Segundo Sub-Office. In 2010, she was promoted to Regional Audit Manager for the West Coast Branch. In 2013, Ms. Jones was selected to be the Special Assistant to the Field Detachment Director. In 2015, Ms. Jones was promoted to a Regional Audit Manager in Field Detachment before her reassignment to the Western Region as the Regional Special Programs Manager. In April 2022, she was appointed to the Senior Executive Service as the Corporate Audit Director, the position she currently holds.

Ms. Jones holds a Master of Science in Strategic Studies from the U.S. Army War College, a Master of Arts in Organizational Management from University of Phoenix and a Bachelor in Accounting from Loyola Marymount University. She is also a graduate of the Defense Senior Leadership Development Program and the Director’s Developmental Program in Leadership. Her certifications include Certified Public Accountant in the State of California and Certified Level III in Defense Acquisition Workforce Improvement Act.
