## SCOTT A. MCLAUGHLIN, JR.

Scott A. McLaughlin, Jr. serves as the Branch Chief of Data Analytics Integration (AFAA/DSAI) at the Air Force Audit Agency. He leads a specialized team responsible for designing, implementing, and maintaining analytical tools, platforms, and dashboards that support both internal agency operations and Department of the Air Force stakeholders. Under his leadership, the branch develops scalable, adaptable solutions and harnesses emerging technologies to promote continuous process improvements and fosters a culture of innovation within the agency.

Prior to his current position, Mr. McLaughlin completed a developmental assignment as an International Budget Analyst with the Office of the Under Secretary of Defense Comptroller, Operations Directorate, Pentagon, Washington D.C. In this role, he was responsible for managing funding exceeding \$110B across multiple fiscal years supporting direct military and DoD assistance, Presidential Drawdown Authority, and Ukraine security assistance. He also served as a Staff Auditor with the Director of Staff, Liaison and Follow-up Team (AFAA/DS) for the Auditor General of the Air Force, Washington D.C. responsible for coordination on all DoD Office of the Inspector General, Government



Accountability Office, and Air Force Audit Agency enterprise-level audit services.

Mr. McLaughlin began his federal career in 2000 as a Security Forces Journeyman and Financial Management Specialist with the Alabama Air National Guard (ALANG), a role he held until December 2006. During this time, he served on Active Duty in support of Operations Enduring Freedom and Iraqi Freedom. Following his service, he transitioned to private industry, working for two public accounting firms, where he gained extensive expertise across public, private, and governmental sectors. In 2011, he returned to federal service as an auditor with the Internal Review Division at ALANG Headquarters, serving as auditor-in-charge. He later held several financial management positions at the Air Force Life Cycle Management Center, including systems accountant, staff accountant, and resource advisor, before assuming the role of Audit Manager with the Air Force Audit Agency's Cyber and Space Operations Division.
