
Donjette L. Gilmore



Auditor General of the Navy



Ms. Donjette L. Gilmore serves as the Auditor General of the Navy, leading the Naval Audit Service in overseeing the internal audit function for the Department of the Navy's \$255 billion budget and 600,000 + military and civilian personnel. She is responsible for the strategic direction and execution of independent audits that enhance efficiency, accountability, and program effectiveness across Navy operations worldwide. Ms. Gilmore's career reflects her dedication to financial integrity, accountability, excellence in public service.

June 2022 - Present: Auditor General of the Navy, Department of the Navy (DON). Leads the internal audit function for DON, directing all internal audit activities worldwide with a \$50 million budget.

From October 2019 - June 2022, Ms. Gilmore served as the Executive Director, Public Private Partnership (PPP) Audit-Level Reviews, DON. She established independent audit oversight for 42 privatized family housing projects worth \$10 billion, ensuring long-term financial viability and quality housing for Sailors and Marines, Civilians, and their families.

From January 2017- February 2019, she served as the Acting Auditor General of the Navy, DON. She served as the senior audit official while continuing to serve as the Deputy Auditor General.

From November 2015 - June 2022, Ms. Gilmore served as the Deputy Auditor General of the Navy, DON. She led the Naval Audit Service, managing a \$46 million budget and 320 professionals, providing audit-related counsel to senior DON leadership.

From July 2010 - November 2015, Ms. Gilmore served as the Director Accounting & Finance Policy, Office of the Under Secretary of Defense (Comptroller). She led the 7,200-page DoD Financial Management Regulation (FMR) modernization at zero cost, impacting 2.2 million DoD users, and countless other users, optimizing financial statement audit preparation and financial management. Ms. Gilmore was appointed by the Executive Office of the President to serve as Chairperson, for the Accounting and Audit Policy Committee, Federal Accounting Standards Advisory Board (effective February 2025, Accounting Standards Implementation Committee) to resolve DoD and government-wide-general property, plant, and equipment accounting issues and establish new DoD capitalization thresholds and issued critical Technical Releases 10 - 15.

From February 2006 - July 2010, she served as the Assistant Chief Information Officer, Business Transformation, National Geospatial-Intelligence Agency. There she spearheaded financial policy and audit readiness efforts for NGA.

From October 2007 - October 2009, Ms. Gilmore served as the Acting Assistant Deputy Chief Financial Officer, Special Assistant to the Deputy Chief Financial Officer, and Assistant Director, Accounting & Finance Policy, Office of the Under Secretary of Defense (Comptroller).

Ms. Gilmore held various Leadership Positions within Air Force Audit Agency (AFAA). She served as Deputy Assistant Auditor General and Director of Policy, Oversight & Systems, and Office Chief. Led financial oversight and audit initiatives supporting Air Force operations. She was also selected to serve as Assistant Inspector General for Inspections, Policy & Oversight (Iraq), Coalition Provisional Authority where she oversaw \$18.5 billion in Iraq reconstruction funds.

Ms. Gilmore earned a B.S. in Accounting and Finance from Auburn University, Auburn, AL and an MBA from Washington University, St. Louis, Mo. She is a graduate of several prestigious leadership programs including the Harvard Senior Executive Fellows Program, the DoD Executive Leadership Development Program, the Air War College, Maxwell AFB, AL and the Air Command and Staff College, Maxwell AFB, AL.

Ms. Gilmore received numerous awards, including Office of the Secretary of Defense (OSD) Exceptional Service Award, Secretary of Defense Joint Meritorious Unit Award, OSD Award for Excellence, American Society of Military Comptroller's Distinguished Performance Team Award – Modernization of the DoD FMR – Team Leader, AFAA Civilian Meritorious Service Award (2x), AFAA Auditor of the Year, National Geospatial-Intelligence Agency (NGA) Civilian Meritorious Service Award, Inductee, Robert E. Lee High School Hall of Fame, Montgomery, AL.

Ms. Gilmore's other achievements include leading DoD's \$367 billion accelerated payments initiative to support small businesses, recognized by the Harvard Business Review. She located the \$8.7 billion in Iraq Development Funds resolving an international concern raised by Iraq and improved DoD audit readiness.

She is also a Certified Defense Financial Manager (CDFM) and holds a DoD Financial Management Certification (DODFML3).
